2.0 MAYOR'S OPENING REMARKS

2.1 Mayor Bryce Nimmo presented a letter from Hon. Ray Danyluk, Minister of Municipal Affairs and Housing announcing that Drumheller will receive an unconditional municipal grant of \$23,960.

2.2 Mayor B. Nimmo presented a letter from Hon. Ray Danyluk, Minister of Municipal Affairs and Housing advising that the Municipal Sustainability Initiative will provide municipalities with an additional \$400 million in funding assistance this year. This is the first step in fulfilling Premier Stelmach's commitment to provide predictable, sustainable funding for Alberta's municipal governments.

2.3 Mayor B. Nimmo presented a letter from Hon. Guy Boutilier, Minister of International, Intergovernmental and Aboriginal Relations advising that Alberta and British Columbia have signed the Trade, Investment and Labour Mobility Agreement (TILMA) on April 28, 2006. In his letter, Hon. Boutilier explains that TILMA is a landmark agreement intended to ease the movement of goods, services and investments between the two provinces. Several consultation sessions are being held across the Province.

2.4 Mayor B. Nimmo presented a letter from Jo-ann Burton, District Coordinator, Prairies, Muscular Dystrophy Canada acknowledging the efforts of the Drumheller Fire Department, whose hard work on behalf of MDC in 2006/07 resulted in a contribution of \$3,880.00 to help their organization achieve it's goals.

8.1 CAO

8.1.1 RFD – Canada-Alberta Municipal Rural Infrastructure Fund (CAMRIF) Application for the Badlands Community Facility

R. Romanetz advised that Leanna Mohan, Fundraising Coordinator provided an overview of the Badlands Community Facility CAMRIF Application to Council at their Committee meeting of May 22nd. The project includes two phases: Phase 1 (Stand Alone Facility) – Field House, Meeting Rooms, Administration Area, Running Track and General Fitness Area; Phase 2 (Future Connected Facility) – Future Curling Rink and Future Ice Surface. Phase 1 is estimated to be \$22,280,000. Drumheller will be able to attract regional and international events and conferences with a new facility bringing increased revenue for the Town and the Downtown Core. The deadline for the application for funding under the CAMRIF is May 31, 2007. All applications for funding under this program require a formal motion from Council approving the request for grant funding.

MO2007.119 Sparling, Shoff that Council direct Administration to submit the detailed grant application for the "Badlands Community Facility" under the Canada-Alberta Municipal Rural Infrastructure Fund as presented.

Councillor K. MacKinnon asked if the project manager was identified properly on the application. R. Romanetz stated that as a result of bringing this to his attention at the Committee Meeting of May 22nd, the front page of the application has now been changed to identify Leanna Mohan as the Fundraising Coordinator and himself as the Project Manager however the Steering Committee as a whole now oversees the project. Councillor T. Yemen asked when the plebiscite question would be put forward. Mayor B. Nimmo stated that the plebiscite will be held prior to the formal approval of the project to determine the location and if the people want the project. He further stated that he would like Council to discuss a plebiscite date at their next Committee of the Whole as well as identifying a strategy for the next steps.

Yemen, board representative to the Drumheller & District Seniors' Foundation, advised that the Foundation anticipates a 20% increase for their project which equates to an increased borrowing of \$3.5 million. He further noted that they will be able to service the debt however with the additional borrowing they have reached their debt limit.
