# 8.1 CAO

8.1.1 RFD – Municipal Sustainability Initiatives Long Term Funding Agreement

CAO R. Romanetz advised that further to Council signing the Municipal Sustainability Initiative (MSI) Grant Program for 2007 whereby the Town will receive funding in the amount of \$513,228.00, the Town has received a long term funding agreement from the Province for the remaining nine years. He further advised that the Province has agreed to a funding commitment for 10 years which will allow municipalities to plan on a long term basis. He explained that a capital project approved under the MSI must meet the grant objectives to work together in partnership with other municipalities to manage growth pressures and support infrastructure needs. The guidelines not been received as of yet.

**MO2007.199** Bertamini, Yemen that Council approve the Memorandum of Agreement under the Municipal Sustainability Initiative Capital Project Funding between Alberta Municipal Affairs and Housing and the Town of Drumheller for the remaining life of the

agreement. Carried.

8.1.2 Information - Canadian Badlands Ltd. Appointments

R. Romanetz advised that the Canadian Badlands Ltd. are proposing changes to the Articles of Association at their annual meeting to be held on November 9<sup>th</sup>. He further advised that Mayor Bryce Nimmo, Councillor Karen Ann Bertamini and Ray Telford were appointed this evening to the Board and they will provide a report on the changes and impact this may have on municipalities. Mayor Bryce Nimmo advised that in order for the organization to continue for the time being the appointments have been assigned for continuity.

#### 8.1.3 RFD – Subdivision and Development Appeal Board Appointments

R. Romanetz advised that the terms of the current SDAB members expire on October 29, 2007 resulting in three vacancies on this board. Three applicants have submitted their names: Mrs. Carol Ludwig, Mr. Trevor Gough, and Mr. Michael Kostynuk. Both Carol and Trevor have previously served on this board and Michael has served on the Municipal Planning Commission. The term of the membership expires on the date of the 2008 Annual Organizational meeting.

**MO2007.200** Guidolin, Shoff that Council approve the appointments of Mrs. Carol Ludwig, Mr. Trevor Gough and Mr. Michael Kostynuk to the Subdivision and Development Appeal Board for a term expiring on the date of the 2008 Annual Organizational Meeting. Carried.

#### 8.2 Acting Director of Infrastructure Services

8.2.1 RFD – East Coulee Sewage Treatment Plant Upgrade Tender Award Steve Huculak advised that the tender for the East Coulee Sewage Treatment Plant Upgrade closed on October 2<sup>nd</sup>, 2007. He advised that of the five contractors initially expressing an interest in the project, only one tender was received prior to the tender closing from Pronghorn Controls Ltd. of Drumheller in the amount of \$98,330 plus contingency and GST. The engineering portion of this project is \$46,000 for a total of \$144,330.00 capital cost. He advised that budget available is \$140,000.00.

**MO2007.201** Shoff, Bertamini that Council authorizes Administration to award the tender for the Coulee Sewage Treatment Plant Upgrade to Pronghorn Controls Ltd. in the amount of \$98,330 plus GST.

#### Discussion on Motion:

Councillor S. Shoff queried a contingency of \$10,000.00. R. Romanetz advised that the contingency is for any unforeseen items that may arise during the retrofit of an older building. Councillor Andrew Berdahl queried the \$4300.00 budget overage. R. Romanetz advised that the difference would be made up from the cost savings on other capital projects or through the operations budget.

Vote on Motion: Carried.

#### 8.3 Director of Corporate Services

8.3.1 RFD – Agreement for Emergency Dispatch Services

In M. Roy's absence (Disaster Services training in Ottawa), R. Romanetz advised that the Town has worked with the City of Red Deer for the last five or six years for the provision of dispatch services. He further advised that the City of Red Deer has provided excellent service. He explained that the new agreement calls for an increase in the per capita rate. Other options would be to pursue other emergency dispatch services however they would have to be tied into the Town's communications systems. He recommended that Council approve an extension for a further five year term.

**MO2007.202** Yemen, McDonald that Council authorize Administration to enter into a five year agreement with the City of Red Deer for the provision of 911 Dispatch Services for the Town of Drumheller.

#### Discussion on Motion:

Councillor K. Bertamini asked if there is an "out" clause. R. Romanetz advised that the contract could be terminated in the case of non performance as outlined in the agreement, however was not aware if an "opt out" clause was included in the agreement.
