5.3. SUBDIVISION AND DEVELOPMENT APPEAL BOARD

5.3.1 RFD - SDAB Appointments

5.5.1 RFD - Drumheller Public Library Board Appointments

The Library Board would like Council's approval for an extension to a third term for Linda Traquair and Margaret Nielson. The term is for three years.
